RACP Response to the Queensland Child Safety Commission of Inquiry

Introduction

The Royal Australasian College of Physicians (RACP) is a membership organisation that connects, trains and represents over 30,000 specialist physicians and trainees from 33 different specialties across Australia and Aotearoa New Zealand, including paediatricians and other specialists with expertise relevant to your Inquiry.

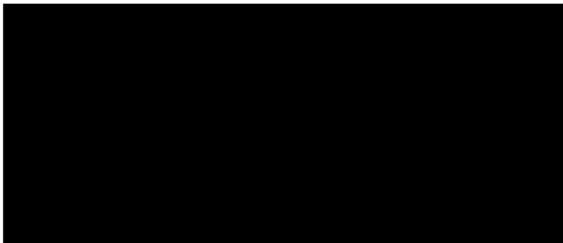

The RACP takes a keen interest in the course and outcomes of your Inquiry.

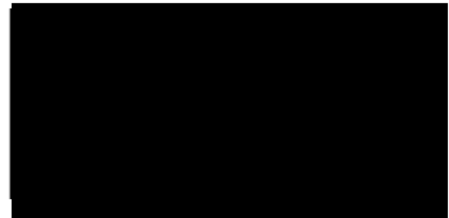
